### Notice of Payment of Interest on Own Capital

Please be informed that, beginning on July 26, 2006, we will start paying interests on own capital, according to deliberation of the Board of Directors during meeting held on June 9, 2006, as follows:

- a) The interest correspond to the value of R\$ 0,09424 per common and preferred shares and will be paid to the shareholders holding these shares on June 9, 2006;
- b) The shareholders will have their credits available from July 26, 2006, according to their current accounts and bank address supplied to Banco Itau S/A., which is the trust depositary bank of the shares;
- c) The value mentioned on item "a" will be subject to Income Tax Withholding in the form of current legislation, except for the shareholders that present, until June 14, 2006, evidence of their immunity or exemption from payment of income tax. Such evidence shall be provided through the delivery of corresponding documents to the Company, on Abramo Randon Avenue, 770, Interlagos District - Zip Code 95055-010, Caxias do Sul, RS, Brazil.
- d) The shareholders in whose reference file the number of CPF / CNPJ (Private Taxpayers' Registry and General Taxpayers' Registry), the indication of Bank/agency and the number of the current account are missing, will have their interest credited on the 3 (three) working days following the completion of such reference file at any agency of Banco Itaú S.A.;
- e) The shareholders will be assisted during banking hours, at the agencies below of Banco Itaú S.A:

- f) The value of interest on own capital, credited to the shareholders in the 2006 fiscal period, may be allocated to dividends relative to the same period, as to be deliberated during the next Ordinary General Meeting. If they are effectively allocated, they will integrate the amount of dividends distributed by the company for all effects foreseen in the corporate legislation.
