Date, time and venue: April 13, 2007, at 3:00 PM, at the company's headquarters, in Caxias do Sul, RS, on Abramo Randon Ave, 770, Interlagos District; **(II) Participants:** shareholders representing 92,02% of the voting capital, shareholders holding 58,00% of preferred shares, administrators, audit advisors, and representatives of KPMG Auditores Independentes. **(III) President and Secretary of the Meeting:** Raul Anselmo Randon, as President and David Abramo Randon, as Secretary. **(IV) Legal Publications:** (a) The publication of the Announcements making available the Management documents to shareholders was considered as not necessary, according to Paragraph 5 of Article 133, of the Law 6404/ 76; (b) Management Documents: Published on February 28, 2007, on Gazeta Mercantil, Diário Oficial do Estado do Rio Grande do Sul – Industry and Commerce Insert – and Pioneiro, of Caxias do Sul; (c) Call Notices: Published on the days 28, 29 and 30 of March 2007 on Diário Oficial do Estado do Rio Grande do Sul – Industry and Commerce Insert -, Pioneiro, of Caxias do Sul, and Gazeta Mercantil, São Paulo Branch; **(V) Decisions:** According to the agenda of the day, with all voting, except for those who are legally impeded, when applicable, the shareholders deliberated to: **(i) In an Ordinary General Assembly:** (a) approve the Annual Report, the Financial Statements recorded on sheets 02 to 33 of the General Minutes Book no. 94, registered at the Board of Trade of the State of Rio Grande do Sul on April 4, 2007, under no. 07/006399-0, along with the respective Report of the Independent Auditors and Audit Board, relative to the fiscal year ended on December 31, 2006; (b) approve the allocation of the period net profit of R\$ 133.990.306,57 (one hundred and thirty-three million, nine hundred and ninety thousand, three hundred and six Reais plus fifty-seven cents), that, added of the Revaluation Reserves in the amount of R\$ 14.977,40 (Fourteen thousand, nine hundred and seventy-seven Reais plus forty cents) amounts to R\$ 134.005.283,97 (One hundred and thirty-four million, five thousand, two hundred and eighty-three Reais plus ninety-seven) as follows: Legal Reserve of R\$ R\$ 6.700.264,20 (six million, seven hundred thousand, two hundred and sixty-four Reais, plus twenty cents); Interest on ownership capital attributed to dividends in the amount of R\$

30.925,871,45 (Thirty million, nine hundred and twenty-five thousand, eight hundred and seventy-one Reais plus forty-five cents); Dividends of R\$ 11.904.514,80 (Eleven million, nine hundred and four thousand, five hundred and fourteen Reais and eighty cents) and Reserve for Investments and Working Capital in the amount of R\$ 84.474.633,52 (eighty-four million, four hundred and seventy-four thousand, six hundred and thirty-three Reais plus fifty-two cents). (c) declare dividends of R\$ 38.181.505,53 (thirty-eight million, one hundred and eighty-one thousand, five hundred and five Reais plus fifty-three cents) calculated pursuant the method established in the company's by-laws: after the interest on the interest on the ownership capital is deduced, according to its net withholding tax (pursuant CVM 207/96) and paid to the shareholders from July 26, 2006 on and from January 24, 2007, (Board of Directors Meetings 566 and 578) a value of R\$ 11.904.514,80 (Eleven million, nine hundred and four thousand, five hundred and fourteen Reais plus eighty cents) remains, corresponding to R\$ 0,07370138 per common and preferred share, to be made available to the shareholders from April 24, 2007 on, preceded by a notice to the shareholders published on the newspapers usually utilized by the Company for these matters; (d) vote for 5 (five) members of the Board of Directors for a mandate of 2 (two) years, who will hold office until the Ordinary General Meeting that will deliberate the financial statements of the fiscal period ended on December 31, 2008 takes place. (f) Establish the remuneration amount of the Administrators and Inspectors of the Company. A global annual remuneration of up to R\$ 3.400.000,00 (three million and four hundred thousand Reais) was established as remuneration to the Administrators for the period May 2007 to April 2008, remaining as the Board of Director's responsibility to decide on the allocation per member in a specific meeting; to the members of the Audit Board, a monthly individual remuneration of 10% (ten percent) of the remuneration established to each Director was set, on average, without considering participation in the profits. **(ii) In an Extraordinary General Meeting:** (a) adjust the Company's by-laws to the capital increase within the authorized limit decided by the Board of Directors on the Board of Directors' Meeting no. 562, held on May 10, 2006, with the article 5th of the mentioned by-laws reading as follows: Article 5th: The capital is R\$ 279.000.000,00 (Two hundred and seventy-nine million Reais) represented by 162.523.635 (one hundred and sixty-two million, five hundred and twenty-three



thousand, six hundred and thirty-five) shares, being 54.592.196 (fifty-four million, five hundred and ninety-two thousand and one hundred and ninety-six) common shares and 107.931.439 (One hundred and seven million, nine hundred and thirty-one thousand, four hundred and thirty-nine) preferred shares, all uncertificated and without nominal value". (iii) Authorize the publication of these minutes with the omission of the shareholders` signatures, according to paragraph 2 of Article 130 of the Law 6.404/76.
